**Hazardous Nature:**

Classified as Hazardous according to the Globally Harmonised System of Classification and Labelling of Chemicals (GHS) and Safe Work Australia criteria.

## 4 First Aid Measures

**Inhalation:** If inhaled, remove to fresh air. Seek medical attention if breathing problems develop.

**Conditions for Safe Storage:**

Store in a cool, dry and well ventilated area, under 30 °C. Keep container tightly closed when not in use. Keep from direct sunlight. Keep from strong oxidising agents and strong alkalis.

## 8 Exposure Controls and Personal Protection
