FIRST AID MEASURES

FIRST AID

Ingestion: Wash mouth with water. If poisoning occurs, contact a Doctor or Poisons Information

Centre. Phone 131 126. Give water to drink.

Eye contact: Brush granules gently away. Hold eyes open and flood with clean water. Ensure irrigation

under eyelids by occasionally lifting them. Do not try to remove contact lenses unless

trained. If irritation persists, seek medical advice.

Skin contact: Brush granules gently off clothing and skin. Remove contaminated clothing. Wash skin

thoroughly with soap and water. If skin is irritated, seek medical advice.

Inhalation: Remove from exposure and observe until recovered. If effects persist, seek medical

advice.

Advice to Doctor: Bifenthrin is a pyrethroid insecticide and about 2% of the formulation. In cases of skin contact, it has been reported that topical applications of Vitamin E acetate were found to have very high therapeutic value, eliminating almost 100% of the skin pain associated with synthetic pyrethroids.

SECTION 5

FIRE FIGHTING MEASURES

Specific Hazard: The product is not combustible.

Extinguishing media: Not combustible. Use extinguishing media suited to burning materials.

Hazards from combustion products: There is no risk of an explosion from this product under normal circumstances if it is involved in a fire. This product is likely to decompose only after heating to dryness, followed by further strong heating. Fire decomposition products from this product may be toxic if inhaled. Take appropriate protective measures.

Precautions for fire-fighters and special protective equipment: Isolate fire area. Evacuate downwind residents. Wear full protective clothing and self-contained breathing apparatus if risk of exposure to vapour or smoke. Do not breathe smoke or vapours generated.

ACCIDENTAL RELEASE MEASURES

Emergency procedures: Extinguish all sources of ignition. Wear cotton overalls and chemical resistant gloves. If material is leaking from a container, stop the leak only if this can be done safely. Prevent spillage entering drains or watercourses. Large spills should be dyked or covered to prevent dispersal. Collect recoverable product for use as labelled on the product. HANDLING AND STORAGE

Precautions for Safe Handling: Wash hands after use. Keep away from domestic pets, especially dogs. If dogs eat the granules, contact your veterinary surgeon immediately. Cover fishponds, aquariums before application. Ensure no granules enter the water.

Conditions for Safe Storage: Store in the closed, original container in a well ventilated area away from children, animals, food, feedstuffs, seed and fertilisers. Do not store for prolonged periods in direct sunlight. Not classified as a Dangerous Good.

STABILITY AND REACTIVITY

Chemical Stability: Product is considered stable in ambient conditions for a period of at least 2 years after manufacture.

Conditions to avoid: Do not store for prolonged periods in direct sunlight. Avoid alkaline materials.

Incompatible materials: Avoid strong acids, bases and oxidizing agents.

Hazardous decomposition products: This product is likely to decompose only after being directly subjected to fire. Toxic and noxious fumes will then be released.

Hazardous reactions: No particular reactions to avoid.

SECTION 11

TOXICOLOGICAL INFORMATION

No specific data is available for this product as no toxicity tests have been conducted on this product. Information presented is our best judgement based on similar products and/or individual components. As with all products for which limited data is available, caution must be exercised through the use of protective equipment and handling procedures to minimise exposure. This formulation contains aromatic hydrocarbons.

SECTION 11 TOXICOLOGICAL INFORMATION (Continued)

Potential Health Effects:

ACUTE EFFECTS

Swallowed: Calculated toxicity is low with $LD_{50} > 5000$ mg/kg.

Eye: Non-irritating to the eye. Excessive exposure to granules may cause irritation to the eyes.

This product contains a granular material that may cause mechanical irritation to the eyes.

Issued: September 2021

Skin: Non-irritating to the skin. Acute Dermal LD₅₀ (rabbit) > 2000 mg/kg. **Inhaled:** As this product is a granule it is unlikely to be an inhalation hazard.

<u>Chronic</u>: No data available on this formulation. In studies with laboratory animals, Bifenthrin Technical (the active ingredient in this product) did not cause teratogenicity or reproductive toxicity. Tremors were associated with repeated exposure of dogs, rats, rabbits, and mice to bifenthrin.

The overall results from a battery of genotoxicity studies indicate that bifenthrin is not considered to be genotoxic. Ames test results were negative.

SECTION 12

ECOLOGICAL INFORMATION

Environmental Toxicology: No data is available on this product. Bifenthrin is highly toxic to fish and aquatic arthropods with LC $_{50}$ values ranging from 0.0038 μ g/L to 17.8 μ g/L. In general, the aquatic arthropods are the most sensitive species. Care should be taken to avoid contamination of the aquatic environment. Bifenthrin had no effect on molluscs at its limit of water solubility. Bifenthrin is only slightly toxic to both waterfowl and upland game birds (LC $_{50}$ values range from 1800 mg/kg to > 2,150 mg/kg).

Before treatment, remove animals and pets from the areas to be treated. Cover or remove any open food and water containers. Keep away from domestic pets, especially dogs. If dogs eat the granules, contact your veterinary surgeon immediately. Use with caution around pets - ensure product is well dispersed i.e. swept in between pavers, cracks, and crevices and dispersed into soil and/or lawn. Cover or remove fishponds, aquariums etc before application. DO NOT apply Apparent Ant-Assassin Granular Ant Killer within 2 metres of a fishpond or water containing fish or aquatic species.

Environmental Fate: No data is available on this product. The active ingredient, bifenthrin (0.2%), degrades at a moderate rate in soils ($t\frac{1}{2} = 50$ to 205 days), and more rapidly on the surface of bare soils ($t\frac{1}{2} = 7$ to 62 days). Bifenthrin is tightly bound in most soils and an extremely low water solubility. Bifenthrin is highly toxic to aquatic organisms.

DO NOT contaminate streams, rivers or waterways with this product or the used containers.

SECTION 13

DISPOSAL CONSIDERATIONS

Spills and Disposal: Persons involved in cleanup require adequate skin protection - see Section 8. Keep out animals and unprotected persons. Keep material out of streams and sewers. Vacuum, shovel or pump waste into an approved drum. Dispose of drummed wastes, including decontamination solution in accordance with the requirements of Local or State Waste Management Authorities.

Disposal of empty containers: Store in the closed, original container in a cool, dry place out of reach of children and pets. DO NOT store in direct sunlight. Dispose of empty containers by wrapping in paper, placing in a plastic bag and putting in garbage bin.
