#### GENERAL INSTRUCTIONS

#### HOW TO PREPARE:

Product can be applied with most garden sprayers. Avoid using fine droplets or applying product in windy conditions as this will increase spray drift. It is important to apply the recommended spray mixture when weeds are young and actively growing. When applying product ensure the amount of spray mixture used corresponds to the recommended area of lawn to be treated. Rain within 24 hours of application may affect the results.

**CAUTION:** DO NOT allow spray to contact or drift onto plants you do not want killed. DO NOT apply within the drip line of shallow rooted trees or shrubs or apply product in areas where chemical may be washed into contact with the roots of desirable plants, DO NOT allow chemical containers or sprays to get into drains, sewers, streams or ponds. DO NOT feed grass clippings from treated areas to poultry or other animals. Equipment used to spray this product should not be used for applying other materials to sensitive plants. If such use is unavailable, clean equipment thoroughly with ammonia or washing soda and rinse with several changes of water and detergent.

#### STORAGE AND DISPOSAL

Store in the closed, original container in a cool, dry place out of the reach of children. Do not store in direct sunlight, Dispose of empty container by wrapping in paper, placing in plastic bag and putting in the garbage.
