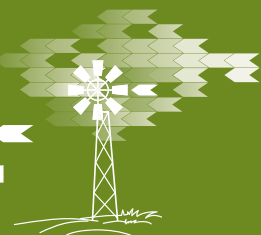

STORAGE AND DISPOSAL

Store in the closed, original container in a dry, well-ventilated area, as cool as possible but out of direct sunlight. Store in a locked room or a place away from children, animals, food, feedstuffs, seed and fertilisers.

Non-returnable Containers: Triple rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant local, state or territory government regulations. DO NOT burn empty containers or product.

For Refillable Containers: Storage must be secure so that containers cannot be tampered with. All locks and/or seals must be in order. If locks or seals are broken prior to initial use then the integrity of this product cannot be assured. If this occurs AIRR Apparent Pty Ltd should be advised immediately. Empty contents fully into application equipment. Close all valves and return to point of supply for refill or storage.

SAFETY DIRECTIONS

Very dangerous. Poisonous if absorbed by skin contact, inhaled or swallowed. Will irritate the eyes, nose, throat and skin. Avoid contact with eyes and skin. DO NOT inhale spray mist. When preparing spray and using the prepared spray, wear cotton overalls buttoned to the

neck and wrist, washable hat, elbow-length PVC gloves and face shield or goggles and half-face respirator or disposable respirator. If clothing becomes contaminated with product or wet with spray remove clothing immediately. If product on skin, immediately wash area with soap and water. After use and before eating, drinking or smoking, wash hands, arms and face thoroughly with soap and water. After each day's use, wash gloves, face shield or goggles, respirator (and if rubber wash with detergent and warm water), face shield and contaminated clothing.

FIRST AID
