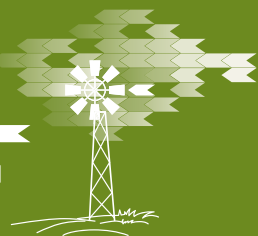

DIRECTIONS FOR USE:

SITUATION	RATE	CRITICAL COMMENTS
Minimise antagonism to tank mixes with flowable herbicides.	2 L/100 L of spray solution.	1. Half fill spray tank with clean water and start agitation. 2. Add Apparent AMS Herbicide Adjuvant through the top opening of spray tank. 3. With agitation still running, add the required flowable herbicide to the tank and mix thoroughly. 4. Add the required amount of Glyphosate based product and the remaining water; mix thoroughly. 5. Add surfactant, if required, near the end of the filling process to minimise foaming. 6. Always maintain adequate agitation during application and use the tank mix promptly.

GENERAL INSTRUCTIONS

Apparent AMS Herbicide Adjuvant should be used with non-selective herbicides only, as with some selective herbicides use may result in loss of selectivity and therefore crop damage. Ammonium Sulphate may be corrosive to metal parts of the sprayer. Thoroughly flush tanks, pumps and nozzles with water after use.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

DO NOT contaminate streams, rivers or water-ways with the chemical or used containers.

STORAGE AND DISPOSAL

KEEP OUT OF REACH OF CHILDREN. Store in the closed, original container in a dry, cool, well-ventilated area. DO NOT store for long periods in direct sunlight.

Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on-site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and deliver empty packaging for appropriate disposal to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation

and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product. **Returnable containers:** Empty contents fully into application equipment. Close all valves and return to point of supply for refill or storage.

SAFETY DIRECTIONS:

Avoid contact with skin and eyes. Wear overalls, rubber gloves, goggles or disposable face shield. After each day's use, wash contaminated clothing, gloves and face shield with soap and water.
