STORAGE & DISPOSAL

Store in the closed original container in a dry, cool, well-ventilated area out of direct sunlight. Single rinse or shake remainder into spray tank or dip. Do not dispose of undiluted chemicals on site. Puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant local, state or territory government regulations. Do not burn empty containers or product. **Spent dips:** Unused or spent dips should be disposed of carefully to avoid contamination of wetlands or watercourses. Dispose of dip in an authorised dip disposal facility. If an authorised dip disposal facility is not available, the spent dip should be evenly spread over flat land not exceeding 20,000 L/ha. The disposal site must be dedicated and adequately banded (soil at least 15 cm high). DO NOT dispose unwanted spent dip in the same place repeatedly, as repeated depositions in one location may, over time, create a contaminated site.

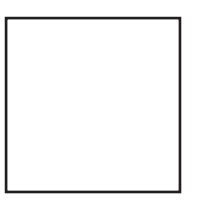
