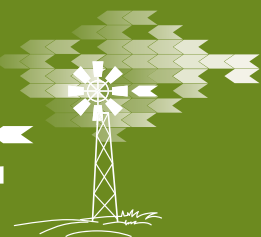

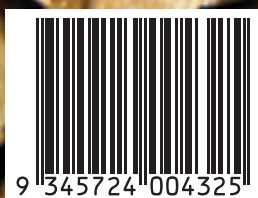

## Apparent Axeman 600 HERBICIDE

### STORAGE AND DISPOSAL

Store in the closed original container in a cool, well-ventilated area. DO NOT store for prolonged periods in direct sunlight. Triple or preferably pressure rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush or puncture and bury empty containers in a local authority landfill. If no landfill is available, bury the containers below 500mm in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots. Empty containers and product should not be burnt.

### SAFETY DIRECTIONS

Poisonous if swallowed. May irritate the eyes and skin. Avoid contact with eyes and skin. If in eyes, hold eyes open, flood with water for at least 15 minutes and see a doctor. When opening the container, preparing spray and using the prepared spray, wear cotton overalls buttoned to the neck

Additional information required under the Globally Harmonised System (GHS) classification of the substance/mixture:  
**Combustible liquid. Causes skin irritation. May cause an allergic skin reaction. Causes eye irritation.**  
Keep away from heat/sparks/open flames/hot surfaces: - No smoking. Avoid breathing mist, vapours or spray. Contaminated work clothing should not be allowed out of the workplace. IF ON SKIN: Wash with plenty of soap and water. IF IN EYES: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If skin irritation occurs: Get medical advice/attention. If skin irritation or rash occurs: Get medical advice/attention. In case of fire: Use foam blanket, carbon dioxide or dry agent for extinction.
