# Apparent Woody Extra HERBICIDE

### STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well ventilated area. DO NOT store for prolonged periods in direct sunlight.

DO NOT store near food, feedstuffs, fertilisers or seed. The method of disposal of the container depends on the container type. Read the STORAGE AND DISPOSAL instructions on the label attached to the container.

**5, 10 and 20 L containers:** This container can be recycled if it is clean, dry, free of visible residues and has the drumMUSTER logo visible. Triple rinse container for disposal. Dispose of rinsate by adding to the spray tank. Do not dispose of undiluted chemicals on site. Wash outside of the container and the cap. Store cleaned container in a sheltered place with cap removed. It will then be acceptable for recycling at any drumMUSTER collection or similar container management site. The cap should not be replaced but may be taken separately. If not recycling, break, crush or puncture and deliver empty packaging for appropriate disposal to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.

**500 mL and 1L containers:** Triple-rinse containers before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. If not recycling, break, crush or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation and tree roots in compliance with relevant local, state or territory government regulations. Do not burn empty containers or product.

### SPILL MANAGEMENT

Do not touch or walk through spilled material. Wear a face-shield or goggles, overalls buttoned to neck and wrist, chemical resistant gloves and footwear.



Additional statements required by Globally Harmonised System of Classification and Labelling of Chemicals (GHS) and Safe Work Australia:  
Combustible liquid. Harmful if swallowed. Causes skin irritation. Causes serious eye irritation. May cause an allergic skin reaction. Will irritate the eyes and skin. Avoid contact with eyes and skin. If product in eyes, wash it out immediately with water. When opening the container and preparing the spray, wear cotton overalls buttoned to the neck and wrists (or equivalent clothing), elbow-length PVC or nitrile gloves and a face shield or goggles. When using the prepared spray with hand-held application equipment, wear cotton overalls buttoned to the neck and wrists (or equivalent clothing), elbow-length PVC or nitrile gloves. Wash hands after use. After each day's use, wash gloves face shield or goggles and contaminated clothing.
